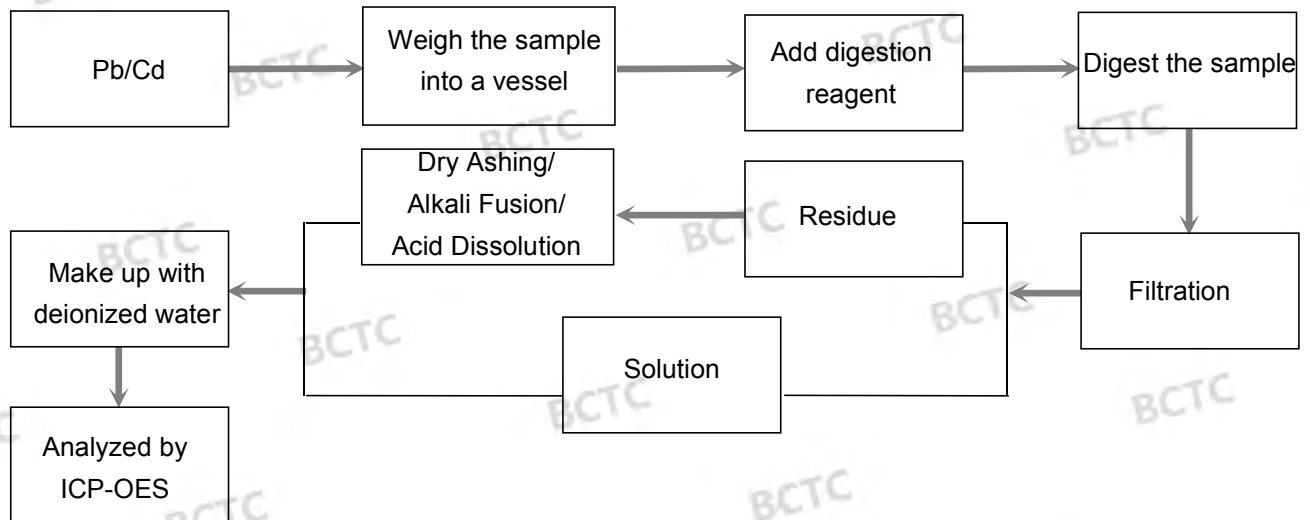

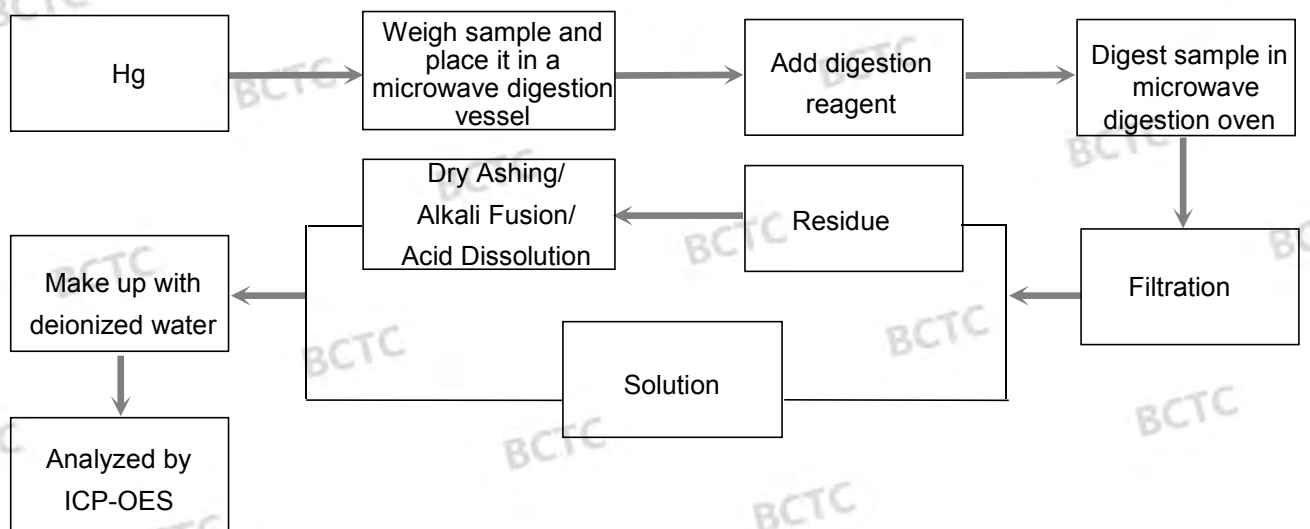

◆ IEC 62321-4:2013+AMD1:2017

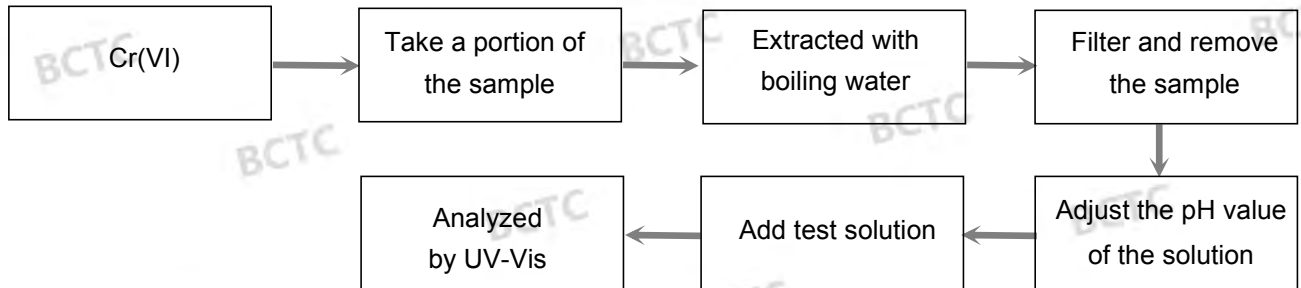

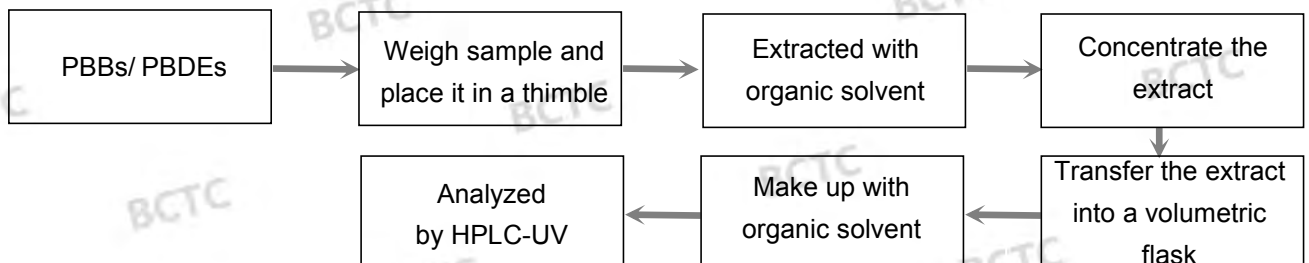

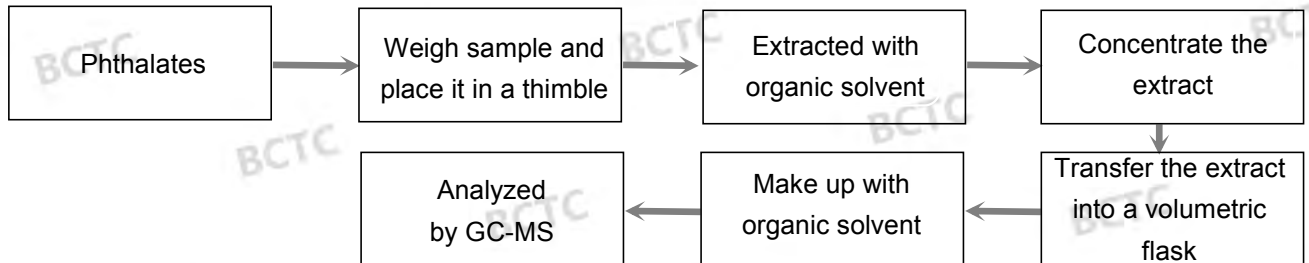

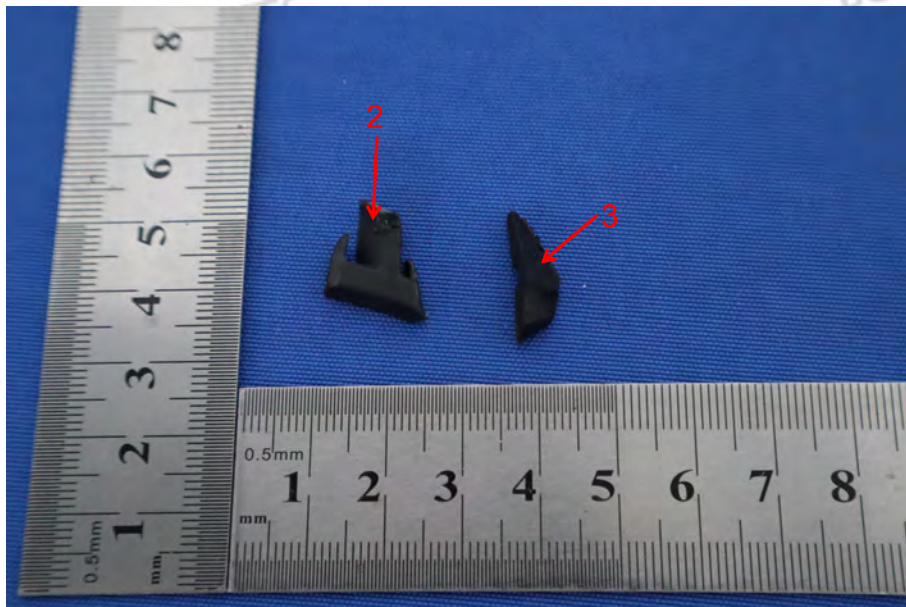

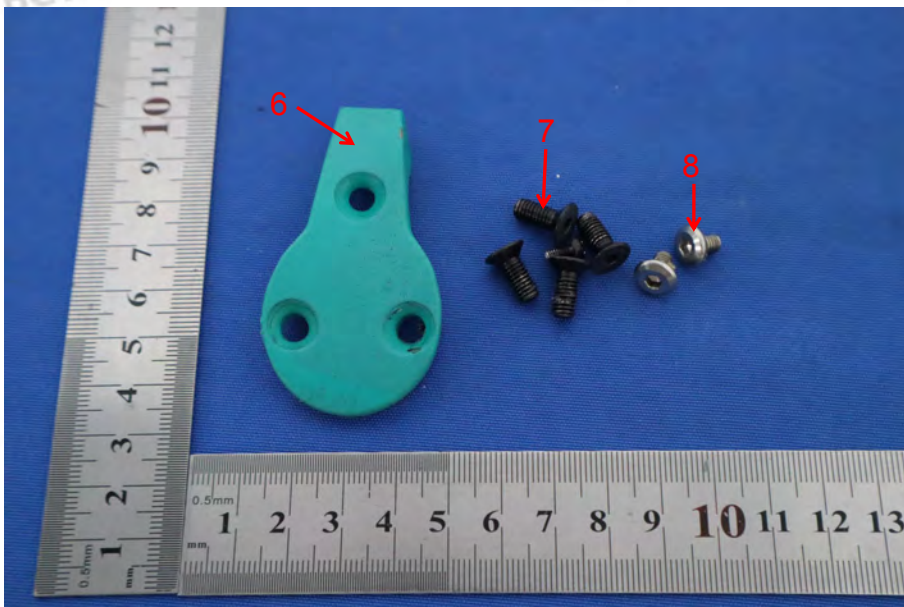
